By placing your NON-Refundable/Tranferrable Deposit \$500 via PayPal (send to friends or family) or other methods (personal check, cash) for the upcoming available cockapoo puppy you have agreed to the following Health Warranty:

NON-REFUNDABLE/TRANSFERABLE DEPOSIT

Deposits are NON Refundable for ANY reason unless at the well puppy checkup my vet finds a health issue that makes the puppy unfit for purchase. If this should happen I will call you to discuss the issue and your options would be 1) refund of your deposit, 2) select an available puppy or 3) go back on the list at the top of the list.

Deposits are NON Transferable. Once you have selected a puppy deposits are not transferable to another puppy or to go back to the Wait List. Once you select a puppy that is the puppy you will go home with unless you forfeit your deposit, place another deposit and 1) select another available puppy or 2) go back on the Wait List at the bottom of the list.

This document acts as a bill of sale (receipt) and/or transfer of ownership from Happy Doodles Place., to the above stated Buyer when all transactions and transfers are made. Puppies picked up, remaining balance \$800 must be paid in CASH ONLY.

Please be sure you are ready to take a puppy home on the dates specified when you select that particular puppy. All puppies MUST go home on dates specified. NO EXCEPTIONS.

These terms are entered into and agreed upon by all parties as of this date, _____ . Therefore it is agreed:

* It is understood that the puppy is sold as a companion only and will not be used for breeding purposes. Spaying or neutering is optional and is NOT required. If the Buyer does opt to Spay or Neuter, the Buyer agrees NOT to have the puppy spayed or neutered prior to 6-month-old. Early Spay or Neuter VOIDS any and all health guarantees. The Buyer understands and accepts this as a condition of the sale of said puppy by initialing here: _____ Date: _____

* This puppy has been delivered to the Buyer with age appropriate inoculations and dewormings. I strongly recommend that your veterinarian also examine this puppy within 72 hours of purchase. This should be a WELLNESS checkup only and NO vaccinations should be given at this time. Failure to follow this protocol VOIDS any and all health guarantees and could potentially jeopardize the health of your puppy. The Buyer understands and accepts this as a condition of the sale of said puppy by initialing here: _____ Date: _____

* This puppy is guaranteed to be free of life threatening congenital defects for one (1) year from date of birth. If a congenital defect is suspected, the Buyer shall notify the Seller within three (3) days of diagnosis and provide the Seller with a veterinarian's written report. The Seller reserves the right to have the dog checked by a veterinarian of our choice and if the prognosis is confirmed, we will replace the dog as availability allows. All warranties are for replacement and/or credit only and not for refund of purchase price in whole or in part or for reimbursement of medical/veterinary expenses in whole or in part. The Buyer understands and accepts this as a condition of the sale of said puppy by initialing here: _____ Date: _____

* The Buyer agrees to harbor this puppy as a "family pet and companion" in the home. The puppy will not be tied out or allowed to roam at large off of the Buyer's property. It is highly recommended that the owner have a completely fenced yard. I do not recommend the use of electronic fences since they are not fool-proof and they do not prevent other animals from entering your yard. The Buyer understands and accepts this as a condition of the sale of said puppy by initialing here: _____ Date: _____

* The Buyer agrees that this puppy will not be subjected to tobacco smoke (pipes, cigars or cigarettes) in its home. The Buyer understands and accepts this as a condition of the sale of said puppy by initialing here: _____ Date: _____

* The Buyer agrees that this puppy will NOT EVER be given any oral Flea and Tick preventative (i.e.; BRAVECTO, NEXGARD, TRIFEXIS). This is due to the history of these products causing life threatening side effects. * The Buyer agrees to vaccinate in accordance with Dr. Jean Dodds' Vaccine Protocol (see attached Helpful Puppy Information for details). The Buyer agrees not to over vaccinate this puppy and to contact the Seller if at any time they have questions regarding immunizations that this puppy (or adult dog) should receive. At no time should this puppy (or adult dog) receive the vaccine for Leptospirosis.
